





World To E1 Upgrade Overview


- Watson Land Current State (2019)
 - Running World for over 20 years current version A9.4 green screen
 - Modules Financials, Real Estate Management, Job Cost, Contract Management, World Reporting Tools
 - Very few customizations
 - High use of FASTR and DreamWriters
- E1 Upgrade Drivers
 - Improved JDE functionality for modules and related reporting
 - Re-designing business processes based on leading industry practices and new capabilities and functionality in JDE E1
 - Transitioning away from the iSeries platform and database onto a new Microsoft infrastructure
 - Improved contemporary user-friendly interface and experience
 - Implement E1 tools and features JDE Orchestrator, E1 Pages, UX One Pages, Grid Overrides, Form Personalizations, etc.

Upgrade Blueprint and Plan

Assessment Project (Phase 0) Overview

Objectives:

- Align Watson's current investment in JD Edwards (JDE) with the most current web application version for improved functionality, infrastructure, reporting and end user satisfaction
- Identify and analyze opportunities to enhance business processes based on leading industry practices, automation and new JDE functionality
- Create an upgrade plan and road map for the JD Edwards upgrade from World to EnterpriseOne (E1) 9.2



Assessment Findings - Functional

Functional Workshops Conducted Accounts Payable Accounts Receivable Accounting Processes & Fixed Asset Management Close Activities **Construction Accounting Construction Operations** Lease/Tenant Creation. Lease Billings & Invoices **Admin & Maintenance Property & Asset Tenant Expense Recovery** Management Master Data/Table Maintenance

In addition to the functional workshops, the following business assessment activities were performed:

- Introduced industrial real estate industry leading practices and net new JDE functionality
- Documented current state issues and opportunities from workshops in the form of meeting notes
- Identified 118 opportunities during the workshops and follow up activities
- Aggregated issues and opportunities from workshops and other discovery activities into Opportunity Matrix
- Analyzed and assessed opportunities by complexity to implement and benefit to Watson
- Grouped all opportunities into initiatives and quick-hit items
- Reviewed completed Opportunity Matrix with Watson executive team and adjusted for feedback





JDE World FASTR reports do not exist in JDE E1

Financial Reporting Options in E1	Description	Considerations
1 - Standard E1 Inquiries & Reports	Large selection of pre-built E1 standard inquiry screens or reports	 Can easily select on certain data and export to Excel May not be the exact report layout to meet Watson's requirements
2 - Financial Report Writer (FRW)	E1 tool to create financial reports and templates (similar to FASTR)	 Reports created by power users or report writers New reports not instantly available (but workarounds exist) Easier if account level of detail is consistent
3 - OneView Financial Reporting (OVFR)	E1 add-on tool to create financial reports and templates	 Reports created by power users or report writers New reports instantly available (like FASTR)
4 - Third Party Excel Based Tool	Excel add-in based third party tool that uses real-time JDE data	 Excel based, so easy to use Separate support and licensing outside Oracle Leading products include ReportsNow, Hubble, Spreadsheet Server

Assessment Findings – FASTR

- Collected all FASTR reports and versions that have been run for past 18 months (475 count)
- Categorized these into 30 unique layouts (all other reports are just data selection variations)
- Feel comfortable that 9 layouts can be addressed by Standard JDE E1 Inquiries or Reports - to be confirmed during upgrade design
- Develop other 21 report layouts during upgrade using Financial Report Writer

Assessment Findings – STAR (Fixed Assets)

- STAR reports are not available in JDE E1 replaced with basic E1 standard inquiries or Enterprise Report Writer
- Collected all World Fixed Asset (STAR) reports and versions that have been run last 18 months (69 count)
- Confirmed that only 35 of these reports and versions are needed going forward
- Categorized these into 5 unique layouts (all other reports are just data selection variations)
- Discovered all 5 layouts share common columns just the sorting and sub-totaling differ
- Develop the 5 reports using Fixed Asset Report Writer in E1

Assessment Findings - World Writer


- World Writer reports are not available in JDE E1 replaced with basic E1 standard inquiries/reports or Enterprise Report Writer
- Collected all World Writer reports and versions that have been run since past 18 months (25 count)
- Analyzed data and layout on reports
- Most reports are detailed GL transaction reports
- All World Writer reports can be addressed through basic E1 standard inquiries or reports
- No custom report writing development identified


Assessment Findings - Customs & Interfaces

Existing Customs & Interfaces



Challenges

- Covid pandemic hit in March 2020 => No project team onsite
 - How do we finish testing, training and deployment?
 - Decision =>>> Stay the course and move forward
 - Watson issued laptops or surface pros to team members
 - Testing continued using MS Teams process was slower
 - Grant Thornton took more active role in integrated testing (tested as a group)
 - Training
 - More targeted courses leveraged user guides
 - Trained heavy users first, then light users
 - Deployment
 - Very detailed cutover plan
 - 2 mock dress rehearsals (including data validation)
 - Open Teams call and phone bridge served as the 'go-live war room'
 - One consultant on-site for Go-Live
 - Support
 - All issues logged with single consultant
 - Daily post go-live start of day and end of day MS Teams meetings

Lessons Learned

- Phase 0 Project Assessment is key to understand upgrade opportunities (process and system), establish scope and estimate upgrade efforts
- Don't under-estimate mock data migrations
 - Improve migration and data validation process each time
 - Understand down time needed for go-live cutover weekend
 - More opportunities to validate solutions to previous data issues
- Identify and execute testing scenarios using both migrated and new data
- You don't need to implement all new functionality and features as part of the original Go-Live – make plans for several optimization phases based on blue-print from assessment phase or project
- Don't underestimate basic change management when moving from World to E1 – everything changes but you can be PREPARED!


